We are pleased to deliver to the Ashtabula County community the first annual report of the accomplishments made possible through the Ashtabula County Senior Services Levy. Thanks to the voters of Ashtabula County, this five year levy has provided the necessary funds to expand and enhance services to senior citizens and their families. This one mill property tax levy, passed by the voters in March 2000, generates approximately \$1.4 million annually to be used for services to Ashtabula County residents age 60 and over.

The following pages detail the programs and activities performed during our first full year in operation. Many of the programs were developed based on a needs assessment study conducted in 1999, which identified five specific categories of services most needed by seniors:

- In-Home care
- Prescription assistance
- Transportation
- Protective services
- Education and wellness.

Newly developed and expanded services are currently being delivered countywide for in-home care, prescription assistance and transportation. Programs for protective services and education and wellness are currently under development and will be available soon.

Each program listed has expectations and performance requirements. We are delighted that the Prescription Assistance for Seniors (PAS) program has already saved senior citizens over **one million dollars** in out-of-pocket expenses for their prescription medication the first year of the program.

An Ashtabula County Senior Services Levy Advisory Board, consisting of local community members, has advised the Commissioners and the Ashtabula County Department of Job and Family Services throughout this process. Their insight and dedication on behalf of senior citizens has been invaluable during the first year of development.

Thank you citizens of Ashtabula County, Ashtabula County Senior Services Levy Advisory Board and staff for the opportunity to provide successful programs for our senior citizens through this much needed levy.

The History of the Ashtabula County Senior Services Levy

According to census data, nearly 20% of the population in Ashtabula County is age 60 and over. As a whole, Ohio will not reach that level until 2015. Over 20% of Ashtabula County Seniors have incomes below poverty level.

In March 2000, voters passed a county wide property tax levy to expand services for senior citizens and their families. This five year, one mill levy is expected to generate approximately \$1,260,000.00 per year. The Ashtabula County Commissioners appointed the Ashtabula County Department of Job and Family Services as administrator of Ashtabula County Senior Services Levy funds.

The Commissioners sponsored a series of focus groups around the County to solicit input from citizens about the services that would best meet the needs of the County's older adults. From that input, five service

categories were established for levy funding. Those five categories are:

- Prescription Assistance
- In-Home Care
- Transportation
- Protective Services
- Education and Wellness

Working on behalf of the Board of Ashtabula County Commissioners, the Ashtabula County Department of Job and Family Services strives to professionally and efficiently administer government programs, including financial assistance, workforce development, medical assistance, child support, social services and public transit, according to laws and regulations established for them. Prescription Assistance for Seniors

The Prescription Assistance for Seniors (PAS) program is designed to assist Ashtabula County residents age 60 and over in obtaining free or reduced cost prescription drugs. The program provides improved access to existing prescription drug assistance programs offered by pharmaceutical manufacturers.

After the Ashtabula County Senior Services Levy passed, the County Commissioners provided funding to begin the program in November 2000, prior to the actual collection of levy revenue. These initial funds allowed the program to run for ten months until a formal Request for Proposal (RFP) process resulted in a one year contracting period for successful proposals.

The Prescription Assistance for Seniors Program targets seniors whose incomes are too high to qualify for Medicaid, but who have no private prescription drug coverage. The service is available to seniors in every township in the County. During the first ten months of the program, seniors assisted through this program realized savings that were nearly twice what it cost to administer the service. The program staff successfully applied for help with over 1,500 prescriptions.

The Ashtabula County Board of Commissioners paved the way for an innovative program to help fill a gap in services for older adults. Many more people are able to maintain their independence and stay in the community longer due to the successful implementation of this program.

Interested seniors may apply for assistance with any of the six agencies funded by the levy to provide the service. Each Agency schedules appointments during business hours and makes home visits as needed.

In-Home Care: Home Delivered Meals

Home Delivered Meals is one of four In-Home Care service categories funded through the Ashtabula Senior Services Levy program. The basic eligibility criteria for the In-Home Care program are:

- Age 60 and over
- Ashtabula County resident
- Frail and/ or homebound
- Verified need (as determined by initial intake assessment)

The Home Delivered Meals program is designed to prepare and deliver one or more meals per day to an individual's residence. The home delivered meals program helps to prevent malnutrition, institutionalization and feelings of isolation.

Ashtabula County Senior Services Levy dollars prevented an extensive waiting list for the home delivered meals program operated by the Community Action Agency. As state funds available continued to decrease, levy funds provided stability to this essential program, saving 93 individuals from being put on a waiting list for service. In the southern townships, levy funds expanded service to townships where no meal service was previously available.


Contracts to provide this service were awarded based on the providers' ability to deliver services to all areas of the County. Levy dollars ensure that any senior who requires a home delivered meal will have a provider ready to provide service in their area.

NOTE: Although this service is available to any resident over the age of 60, 66% of those served in the first year of the program were over age 75. Those over age 75 are the fastest growing segment of the population, and are most at risk of premature institutionalization. There has been a 20% increase in those age 75 and over. Among those served who are over age 75, more than 40% are 85 and older.

In-Home Care: Personal Care

The Personal Care program provides basic health maintenance and personal hygiene assistance to individuals in their own home. These services enable participants to achieve optimal functioning with their activities of daily living.

The contracts for this service were awarded in January 2002, and will run through January 2003. The two service providers will provide service to residents in all townships in Ashtabula County.

The contracts are for "units of service,"

which in the case of personal care is one hour of personal care provided in a recipient's home. Between the two contracts, 5,724 units of service will be provided during the year.

In-Home Care: Chore-Homemaker



The chore-homemaker program provides services which enable recipients to achieve and maintain a clean, safe and healthy environment. Provid-

ers may assist with housecleaning, laundry, meal planning and kitchen care.

The contracts for this service began in January 2002 and will continue through through January 2003. Residents of all townships will be served through this service.

The contracts provide for 6,864 units of service, which is one hour of chore-home-maker service provided in a client's home.

In-Home Care: Minor Home Repair


The final service category under In-Home Care is Minor Home Repair. This service category is currently under development, with funds to be awarded by the end of 2002.

This service will provide one-time assistance to individuals whose homes need minor repairs to ensure the living environment is safe.


Transportation

The Ashtabula County Senior Services Levy is playing a key role in senior citizen transportation in the County. Funds are being used to expand service, create new opportunities and reach a new audience of seniors.

The Ashtabula County Senior Services Levy was able to provide funds to preserve the mid-day service routes on the Ashtabula County Transportation System (ACTS). By maintaining service between



Ashtabula County residents age 60 and over are issued a Senior Bus Pass to use during the mid-day hours. The pass allows them to ride anywhere on the service free of charge.



bor Program qualified for a dual wheel cutaway lift van that will increase the amount of service available to seniors in South County. With a relatively small investment, the Senior Services Levy helped bring another transportation option to residents of

Ashtabula County.

Programs Still To Come

There are still a couple of service categories under development. Those categories include: In-Home Care- Minor Home Repair, Education and Wellness, Protective Services (guardianship, representative payee and ombudsman services) and Transportation. Each of these categories will round out the service delivery system funded by the Ashtabula County Senior Services Levy.

Since this report covers the year ending March 31, information about additional funded transportation projects is not included in the above description. However,

those funds have been allocated, in addition to what is described above.

Under education and wellness, the Levy funds will be spent on innovative programs to meet the needs of the County's mobile older adult population. Protective Services will expand guardianship, develop a payee program and expand ombudsman services, providing greater protection to our County's vulnerable elders. Finally, minor home repair will provide one time assistance to individuals whose homes put them at a safety risk.

Request for Proposal Process

The process of awarding Ashtabula County Senior Services Levy funds conforms with the current county procurement procedures outlined in the Ohio Administrative Procedure Manual (APM). Competitive proposal (APM 4032.2) and non-competitive proposal (APM 4032.3) methods describe the requirements for the purchase of services, supplies or items costing in excess of the small purchase threshold.

As administrator of the Ashtabula County Senior Services Levy funds, the Ashtabula County Department of Job and Family Services provides staff to complete the RFP process, write and monitor contracts and complete invoice processing.

Competitive proposals require a formal Request for Proposal (RFP) bidding process that begins with a publicly advertised notice published once a week for not less than two consecutive weeks preceding the deadline for submission of proposals.

Allowing for a question and answer period, proposal submission and evaluation, the entire process- from advertisement of fund availability to contract award - may take two months or more.

The Board of Ashtabula County Commissioners appointed a ten member advisory board to help oversee the use of the levy funds. The Senior Services Advisory Board serves as a sounding board and voice of the community on the development of levy programs.

Levy funds become available in April of each year, after property tax collections are completed for the first half. During the first year, from April 2001 through March 2002, fourteen contracts were awarded through the RFP process. Each of the providers met stringent requirements to ensure that Ashtabula County seniors receive the best service available.


